The company conducts analysis and valuation of enterprises, acquisition of businesses in financial distress as well as their successful management and development subsequently.

Positive results are evident from the purchase of Chefin Real Estate Bulgaria Ltd. – acquired insolvent in 2013 and now fully operational meeting its liabilities and providing services to MVB Truck and Bus Bulgaria – the official distributor of MAN Truck & Bus AG for Bulgaria.

In 2014 aiming to continue its growth on the automotive market, the company acquired through its subsidiary M-Car Ltd. Skopje the insolvent enterprise representing BMW for Macedonia and Kosovo – the latter restarted its business activities in April 2015.
